**Quorum:** A quorum (>7) of ABS Directors was determined to be present. Count = 11.

**Approval of the 2020 Board meeting minutes:** Unanimously approved.

**Agenda:** One addition (Judge Edwards): Membership Retention (see "Membership Issues")

**Consent Agenda:** The following items were included in the Consent Agenda: Digital Publications and Email Report; Species/Source List Report; Nominations Committee Report; Bamboo of the Americas Report. These are **attached to these minutes**.

The Consent Agenda was approved unanimously on a **motion** by King, second by Edwards. Chapter and International Reports (as available) are **attached**.

**President's Report:** (Luc Boeraeve) – **attached**.

**Treasurer's Report:** (Carole Meckes) -

The YTD income/expense report through 31 August and the proposed budget for 2022 were presented, and the latter is **attached** to these minutes. YTD: Income \$17,366.38; Expenses \$14,393.90.

The bank balance is \$23,914.19, plus \$9,227.12 in PayPal and \$62,806.19 in the TD Ameritrade brokerage account, making the ABS net worth \$95,947.50.

BOTA is a "special project" of the ABS; its accounts are figured internally and are not included here.

\$5000 for grants was allocated for 2021 and forwarded to the Ned Jaquith Foundation.

The annual audit of ABS accounts by the Secretary was accomplished by comparing recent bank statements to the amounts in the Treasurer's reports. No discrepancies were found.

The final 2022 budget and discussion appear under New Business below.

A **motion** (King, second by Edwards) to approve the Treasurer's Report **carried** unanimously.

**Management of Funds in Brokerage Account:** (David King) The funds currently are in 1 mutual fund, several exchange-traded funds and cash, and are doing well since inception in the spring of 2013. David King rebalances the investments from time to time to maintain diversification and a moderate risk allocation. Volunteers to help with the account would be welcome.

**Membership Report** – Membership Report (Carole Meckes): There are currently **299** voting ABS members, and Carole presented the breakdown among chapters. Thus the quorum for the Annual General Meeting will be 30 or more ABS members.

**Secretary's Report** (David King)

A summary of Board actions YTD is **attached**. These meetings were conducted on Zoom, to which the ABS has a subscription.

At-Large #2 Director for 2021-2024 term: Election results to be announced at the upcoming Annual General Membership Meeting.

International Director for 2021-2024 term: Election results to be announced at the upcoming Annual General Membership Meeting.

**Ned Jaquith Foundation (NJF) Grants:** (Nancy Oberschmidt) Grant application deadline is 1 October and decisions should be made by 15 October. Any applications received by the ABS are forwarded to the Ned Jaquith Foundation, which is now the body which reviews and approves grant applications received by either organization. There is a need for a volunteer to follow through on grants given, since sometimes no report or presentation is returned by the grantee. Donations are solicited, as always, especially with the inability to hold an in-person fundraiser during 2020-21.

**Arts/Crafts:** (Shanti Pierce) As the new A&C Coordinator, she has formed a committee which has run a 2021 competition. There were about 20 adults and 10 children submitting their work. Winners will be announced at the General Membership Meeting, and the top winner will be asked to be an "Art Ambassador" for the ABS. An article for BAMBOO Magazine is pending.

**NEW BUSINESS —**

**Annual Review of Electoral Number** (David King): The number of primary ABS members which a chapter must have to be represented by an ABS Director is currently 25. Twenty ABS members are needed to form a chapter. Chapters which are not large enough to have their own Director are represented by the four At-Large members or may share a Director with one or more other Chapters.

A **motion** (King, second: Edwards) to maintain the electoral number at 25, **carried**.

**Membership Issues:**

ABS-only membership for US residents: Officially not allowed but with chapter dissolution, happens in a *de facto* fashion. Comstock pointed out that there are often too few volunteers willing to be meeting organizers at the hosting chapter level, increasing the need for participation by the national ABS in the organization of annual meetings. Discussion only, no action taken.

A **motion** (Connor, second by Saporito) to require all who join ABS under a business name to join at the \$300 Commercial level **failed** on a unanimous vote.

A **motion** (Connor, second by Meckes) to include a chapter membership in the \$300 Commercial level **failed** on a unanimous vote.

A **motion** (King, second by Pierce) to make the payment of dues a recurring auto-charge, with the option for the member to opt-out at any time, **carried**. Shanti Pierce volunteered to compose an email to be sent to members regarding these recurring charges.

Judge Edwards led a discussion of member retention by chapters: retaining the ABS chapter system, having a presence at garden club functions to recruit new members, a personal first contact with new members, and increasing the "fun factor" at events.

**Advertising:** (Carole Meckes for James Clever)

James Clever has called all past advertisers and is making use of the sources in the ABS Species Source List to obtain new or renewing advertisements for the website and printed publications.

**Website Issues:** (Meckes, Comstock)

The "aMember" membership management system is now the ABS membership software and database. It is adequately modifiable and automatic renewal notices and acknowledgments can be sent to members. Carole Meckes has worked long hours to convert member records from the previous database. The Board previously approved \$80/year for aMember tech support.

Portions of the previous ABS Statement on Bamboo Invasiveness appearing on bamboo.org require updating; Ian Connor and James Clever produced an update. With minor changes in wording and the suggested inclusion of images, a **motion** (King, seconded by Pierce) to accept the update **carried**.

**Social Media Management:**

Facebook – The "ABS Members" Facebook group is available to paid ABS members only. After discussion, the Board agreed that the group should remain open to current members only. If a group member's ABS membership expires that member should be removed. Saporito suggested that a yearly review would probably be enough.

Instagram – Started by a volunteer, there is some activity seen.

Shanti Pierce suggested looking into outside management of social media for the ABS, as is done in many other organizations.

**ABS Internal Funding Requests:** (For final figures, see line entries in **attached** budget.)

Websites - \$80 for aMember, Zoom \$150, possibly \$\$ for event software. \$500-\$1000 suggested.

BAMBOO Magazine – no change.

Species Source List printing – Approximately \$2000.

Arts/Crafts - \$100 admin costs, \$2000 prizes.

Advertising – none.

**APPROVAL of the 2022 ABS BUDGET** (All Directors and Officers): A budget (**attached**) was **approved** on a **motion** by King, seconded by Connor.

**Announcement of International Events:** *Luc Boeraeve*

2022 – The 4<sup>th</sup> World Bamboo Workshop will be held in Vietnam 16-20.Sep 2022.

2023 – The location of the next World Bamboo Congress has yet to be announced officially.

**Future ABS Annual Meeting Planning:**

2022 – Florida Caribbean Chapter, Probably Sebastian, FL in early-mid October.

2023 – Louisiana Gulf Coast Chapter, Location to be announced.

2024 – (Need hosting chapter.)

**Future ABS Board Meetings:** Will be continued virtually as needed throughout the year. This has worked out well during the pandemic.

**Approval** of the 30 September Annual ABS General Meeting Agenda was by consensus.

**Item continued** until the Board reconvenes:

The election of officers of the ABS.

**Recess:** A **motion** to **recess** the meeting of the Board until 30 September 2021 gained unanimous approval.

## Secretary's Report: Summary of Board Activity YTD September 2021

The Florida Caribbean Chapter has been reorganized and has an ABS Board Director -- Shanti Pierce.

The Mid-States chapter now has enough primary members to qualify for a Chapter Director on the ABS Board, and may select someone to serve in that position anytime.

The 2021 Arts & Crafts Competition is well underway under the aegis of Shanti Pierce (Florida Caribbean Chapter).

Bamboo.org, the ABS website, has in part been converted to WordPress, making it editable by ABS talent. A consultant introduced to the Board by Robert Saporito has assisted in the conversion. The converted site went live in late July.

The "aMember" membership program has been integrated into bamboo.org, making it easier to join ABS or renew, and track members by chapter. Automatic emails are sent greeting new members and reminding existing members when it comes time to renew.

Carole Meckes has assumed the position of Membership Chair and Co-Treasurer (with Bill Hollenback), and has been instrumental in adopting aMember for use with the ABS membership database.

An online map of bamboo groves in the US is in the works for the ABS website.

For the 2021 Annual Meeting, Kristen Comstock has integrated a meeting registration program into bamboo.org. Access to this software will be available to organizers of future meetings. "Stripe" has been substituted for "PayPal" for registration payment because of better customer service and lesser fees.

Advertising in ABS publications including bamboo.org has been vigorously pursued by James Clever, who has made personal contact with past and present advertisers to encourage ad renewals and payment.

ABS is receiving some income from Amazon Smile, and members are encouraged to use "smile.amazon.com" instead of "amazon.com" for purchases, designating ABS as their charity.

The ABS Director and Officer's liability insurance policy was renewed.

## **ABS President's report for the year 2020 - 2021**

As during the previous year, the covid-19 pandemic continued to have a big impact on all aspects of our day-to-day life and hence as well on our bamboo activities. In 2020 the ABS board and officers started to meet on a regular basis via Zoom and this was continued in 2021. In total 8 virtual board meetings were held since the AGM of last year. In addition the Tech Committee held a number of virtual meetings to work on the website and a membership management system. As a result the board and officers worked closely together throughout the year and maintaining good contacts with the chapters.

In addition to the day to day running of the organization, a big effort went towards revising and updating the website, introducing an efficient membership management system and also supporting the SEC in their preparations of the annual conference.

The revamped technical committee came up with an affordable and efficient membership management system and proposed and introduced major changes to the bamboo.org website. The aMember subscription membership software was selected and integrated with our website. A lot of work went into transferring all membership data to aMember and moving the membership and magazines to the new bamboo.org under aMember. In 2020 the South East Chapter (SEC) made an enormous effort in preparing the annual Conference which was then cancelled following the covid-19 pandemic. Lucky enough, after a long break, the SEC found the energy to start again preparing the annual conference taking place end of September in Georgia. The board followed up the preparations during the year and is now looking forward to a successful conference.

The above is a limited overview and much more work has been and is done by many ABS volunteers, such as producing and distributing the Bamboo magazine, the ABS Journal, Website content, Source and Species List, Grants (with NJF), Help line, BOTA, advertising, social media communication etc.

The strength of Bamboo permeates the ABS and thanks to all of you, board members, job holders and ABS members, Bamboo and the ABS is growing stronger.

## Revised version section September 2021

### Responsible planting and control

If you plant bamboo, you are responsible for its care. Choose your growing site carefully, keeping in mind the intended function of the bamboo (e.g., screen, specimen plant), and type of bamboo and its future growth potential. Select bamboo that grows well in your site and familiarize yourself with the growth characteristics of that species.

The ABS recommends that running bamboos should be planted with an area around the desired footprint of the bamboo that has room for the gardener to do future underground lateral rhizome pruning (curbing) of its spread. Man-made barriers are a tool that can be appropriate in certain installations to assist keeping the bamboo where you want it. Responsible bamboo growers and sellers could assist on installing a physical barrier at the time of planting. The 80 mil. thick HDPE (High Density Polyethylene ) is the best barrier material available at this time, although concrete barriers can be effective as well (if reinforced with rebar and is 30 inches below soil grade). Other thinner plastics are too weak, or not stable enough to hold up to the pressures of rhizome expansion. Avoid metal which will rust, wood (including pressure treated) rots. Finally, a dry moat filled with sand in many cases is effective access to the rhizomes for maintenance. Sand is not a barrier. It is a loose material that is easy to drag a tool through to find the loose rhizomes.

Rhizome pruning needs to be considered as essential maintenance that will keep rhizomes from jumping, or breaking through barriers. The optimum is three times throughout the growing season, (every other month starting mid spring). To facilitate removing rhizomes running along the inner face of the barrier, add sand to 6-12 inches in width to a depth based on your native soil, cultivation and your location. It is found to be much easier than pulling out rhizome roots holding onto dry heavy soil in August heat.

If you must remove unwanted bamboo entirely, the only truly effective way to get rid of it is to dig it out. The ABS does not recommend using chemicals to kill bamboo because of the potential for environmental damage from ground and water contamination and the potential for contact with humans and animals. If you inherit a “problem” bamboo, the fastest and most cost-effective means of removing it or managing it is to hire someone with expertise to assist you.

Growing bamboo responsibly means educating yourself about the plant first, taking the time to plant the bamboo correctly, and most importantly, doing regular maintenance as required. Bamboo, if mistreated and ignored, can grow to be an unruly mess. However, a properly managed bamboo clump or grove is a beautiful sight to behold.

I wanted to move bamboo.org over to the same web account so the sites can share the species/source list (SSL) database but in order to do this I had to update the underlying programming language from version 3 to 7. This caused me to have to update the program that bamboo web relied on for users, photos and SSL. The Style that I used is not compatible any more so I had to recreate a lot of it.

It is about 80% back and I am still working on location/map data, Flowering records and individual plant list entry and editing. Along with updated forms for the ABS Source List entry and print version formatting.

The good thing is this should not happen again because the new changes are more isolated from the underlying forum code and the technology is now 17 years newer. I also have the amember add in so ABS members will only need one login between both sites.

- ✓ 2020 - 2021 was my third year of my 3<sup>rd</sup> 3 year term as International Director of the ABS.
- ✓ As in the previous year, international contacts were limited due to the travel restrictions, particular international travel, in place to fight the covid-19 pandemic. Nevertheless, international contacts took place through on-line conferences, webinars and other on-line tools.
- ✓ Participated throughout the year in a number of webinars, in particular the webinars organised by INBAR.int (see <https://www.inbar.int/inbar-webinars/> ).
- ✓ Maintained close contacts with the German, Dutch and French bamboo societies and, as well with the Belgian Bamboo Society members.
- ✓ The AsIB (Asociación Ibérica del Bambú or Iberian Bamboo Society) was founded this year. A group of participants to the Bamboo Symposium held in Madrid (October 2019) decided to set up a bamboo society and covering both Spain and Portugal. - ✓ Attended the annual meeting of EBS-D, the German bamboo society. Visits to several gardens with bamboo and a botanic garden took place before and after the AGM.
- ✓ The Bamboo Society of Australia (BSA) has problems to find enough volunteers for their board and a special resolution to close the bamboo society is on the agenda of the coming AGM (October 3<sup>rd</sup>).
- ✓ Almost all international events/workshops took place on-line but this might and will hopefully change in 2022. At least one 'live' workshop has been announced: the 4<sup>th</sup> World Bamboo Workshop in Vietnam (September 2022).
- ✓ The number of ABS International members remains stable although an increase would be very welcome.

## **Annual report of the LGCC to the ABS**

## **Northern CA Chapter Report to the ABS Board**

The NCC has been inactive for three years and is considering dissolution. Members and past members have been sent an email soliciting volunteers for leadership (not just helping) positions. Only two or three responses have been received. "Fresh blood" is needed to rejuvenate and/or remake the Chapter into the vibrant organization we once were.

Thus far the NCC tax status is still that of a 501(c)(3) nonprofit. This is nontransferable and will be canceled if we disband.

There is money in the NCC bank account, which would have to be sent to another nonprofit according to IRS and California Nonprofit Corporation rules.

With respect to NCC members (we have 20+ now), they all have been informed of the possible coming changes, and know that they will have the option to transfer to another chapter of their choice. On the West Coast, that means the Pacific Northwest Chapter, the Southern CA Chapter, or perhaps Hawaii, assuming they wish to choose a chapter with a similar climate.

As much as I would like the NCC to survive, I must accept the reality of our predicament with the minor comfort of realizing the same thing is happening to many horticulturally-oriented nonprofits, and we are not alone. There is just too much information on the Internet to compete with, all freely available but without validation as to accuracy or authenticity.

Those who remain active members of the ABS will need to focus on the national organization. I believe the future of the ABS may be to exist as as more than a "mother" club whose chapters are responsible for membership gains and regional activities, but as the primary organizer of such activities as well as the Annual Meeting.

## **The Texas Bamboo Society Annual Report: 2021**

This was an interesting year for the Texas Bamboo Society. February 15 – 17 we saw some of the coldest temperatures ever recorded in central Texas. We were in the single digits (5-9 degrees) for more than 36 hours. Many of the less cold hardy bamboos received significant damage. Clumping *bambusa* varieties, which usually do well in the Texas winters, died to the ground. Plants came back from the roots in the spring.

The Texas Bamboo Society continues to postpone most activities and our annual festival due to covid restrictions implemented by our home base at Zilker Botanical Gardens. All garden clubs are restricted from having meetings and conferences in the club house. However, there continues to be a small group of volunteers that meet every 3<sup>rd</sup> Saturday to groom the groves, harvest poles, and care for the bamboo plantings. Carole Meckes continues as President. Bill Cornelius serves as Vice President. and Wes Maconi continues to serve as treasurer. Harry Simmons has agreed to serve another term as ABS Rep. for the TBS.
